1. INTRODUCTION

Months ago, Pax Consulting published an analysis on Monaco to highlight how the rock was shaped by France and the Russian diaspora which is hosted in the principality.

These high-profile Russians have developed important relationships in the area, of course spreading their influence on the city of Nice and the surrounding departments (Apls, Provence, Côte d'Azur).

Monaco has always been interesting for Russia because it is a region (country) which may be a source of instability for France. Monaco and France are at odds regularly and Russia loves to exploit any opportunity which causes instability within Europe. Although Monaco is not part of the EU, its close relationship with France makes it *de facto* included in the Schengen area. It's the same for San Marino, Andorra or the Vatican City.

In any case, these small territories like Gibraltar, Monaco or Andorra (to name a few) are always the cradle of atypical behavioural patterns. The small population and close relationships among locals are at the core of these peculiarities.

Monaco is remarkable for its high level of life and high financial profile of its foreign hosts, among them, the Russians.

One of the individuals Pax Consulting highlighted in the aforementioned analysis was Dmitri Rybolovlev. A rich businessman, owner of the AS Monaco (football club) who has appeared in the Epstein files.

Rybolovlev has also been linked to Donald Trump in the real estate realm, but not only. We dive deep.

2. RYBOLOVLEV LINKS

A tycoon like Rybolovlev has many key relationships in Russia and elsewhere. In Monaco, such an individual, has access to the very top of the Princedom, where Prince Alberto II has attended many different events in uncountable occasions where Rybolovlev was present, whether as a guest or as the host.

Russian diaspora in Monaco is very well incardinated in the Monégasque high life. Cultural and sport events are organised by Russians, and it opens the gate to high profile citizens from Monaco but also from France.

The Orthodox cathedral in Nice, which involves the activity of members of the Russian Imperial Household, is another mean of building links and friendship in France.

Rybolovlev happens to have bought a house to Donald Trump at a time when Trump was in financial difficulties. In **2008**, during the height of the global financial crisis, Donald Trump sold the *Maison de l'Amitié* (House of Friendship), a 62,000-square-foot oceanfront estate in Palm Beach, to Russian oligarch **Dmitry Rybolovlev** for **\$95 million**. The purchase was made through a Rybolovlev entity named "County Road Property LLC".

The transaction drew significant scrutiny due to the price and timing. Trump had purchased the property at a bankruptcy auction in November 2004 for \$41.35 million. Interestingly, **Jeffrey Epstein was another bidder who kept a war for the house with Trump**. Apparently, it was the end of their relationship.

At the time of the 2008 sale, the Palm Beach County tax appraisal **valued the property at roughly \$60 million**. **Rybolovlev paid \$35 million over the appraised value** at a time when the Florida real estate market was collapsing.

It is to be noted that at the time of the sale, **Trump was in "serious financial trouble" with Deutsche Bank** and critically needed cash.

Rybolovlev never spent a night at the house and in 2016 demolished the mansion. He subdivided the land into three lots, selling them between 2016 and 2019 for a total of approximately **\$108.2 million**. While this figure is higher than the purchase price, after accounting for demolition, carrying costs, and inflation over a decade, it was "not exactly a great trust investment".

In emails to journalist Michael Wolff, **Epstein theorized that the house purchase—and Rybolovlev's later sale of the *Salvator Mundi* painting¹ to Mohammed bin Salman (MBS) for \$450 million—were connected transactions**. Epstein suggested these were disguised payoffs from MBS to Trump (via Rybolovlev) in exchange for U.S. support regarding the war in Yemen and policy toward Iran.

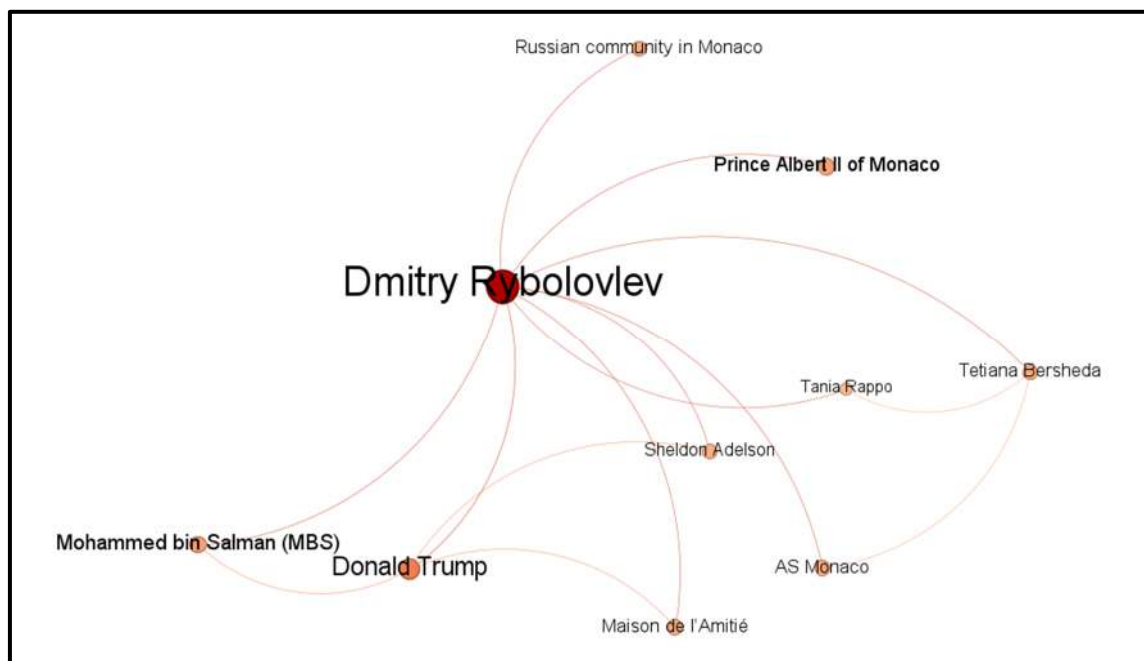
¹ **The *Salvator Mundi*** attributed to Leonardo da Vinci, this painting was purchased by Russian oligarch Dmitry Rybolovlev in 2013 for **\$127.5 million**—a deal that sparked a massive fraud lawsuit against his art dealer, Yves Bouvier. In November 2017, Rybolovlev sold the work at Christie's for a record-breaking **\$450.3 million** to Saudi Crown Prince Mohammed bin Salman (MBS). The painting has not been publicly seen since the sale.

Epstein also suggested that **Trump had historically acted as a "front man" in real estate deals to disguise actual ownership.** Similarly, Trump's former lawyer, Michael Cohen, reportedly claimed **Trump believed Rybolovlev was a "front for Putin".**

Pax Consulting remarks that these are opinions of both, Trump and Epstein and any of this has been verified. Even though Epstein and Trump were close enemies at the time of the comments and emails, both were well-informed individuals.

The sale remains a focal point in investigations regarding the intersection of Russian money, American real estate, and political influence.

This is an extract of Rybolovlev's links who have the highest eigenvector values (the most relevant individuals in his network):



It's remarkable the presence of the head of the State, Prince Albert II, as well as the Crown Prince of Saudi Arabia, MBS.

The Russian community in Monaco is very well connected in France, too. There are two French politicians who stand out related to Russians. Both are linked to Nice, where the Russian diaspora is also very active in cultural and business events.

Those individuals are the incumbent mayor of Nice, Christian Estrosi, and Éric Ciotti, a member of the National Assembly (French Parliament). Ciotti has largely been described as right-wing and of belonging in the right-wing populist faction of The Republicans. On 22 September 2024, Ciotti announced he would leave The Republicans, fully

committing himself to his Union of the Right for the Republic (UDR) party. Both politicians were born in Nice.

3. RYBOLOVLEV AND TRUMP

One of the individuals who link both tycoons is a certain Sheldon Adelson. He is also linked to Jeffrey Epstein.

		(Mandalay Bay). Both men operated as key figures in the same "private intelligence ecosystem" involving Israeli intelligence and influence.

The Intelligence milieu deserves a specific look.

4. EPSTEIN, ADELSON AND INTELLIGENCE

Adelson and Epstein were related to private intelligence corporations and both related to Mossad.

Adelson was a "major funder" of the Foundation for Defense of Democracies (FDD), a hawkish think tank. The FDD board included Ron Wahid, the founder of Arcanum Global—the private intelligence firm hired by Russian oligarch Dmitry Rybolovlev to conduct surveillance.

Adelson is described as the "financial engine" behind the anti-Iran, pro-Israel policy network. **This aligns with the geopolitical goals often pursued by the intelligence firms in this ecosystem (such as Black Cube and Psy-Group).**

Meir Dagan, the former three-term head of **Mossad** (2002–2011), plays the most specific role because he was involved in both firms, Black Cube and Arcanum:

- **Senior Advisor to Arcanum Global:** He was hired in 2012 by Arcanum, the firm paid over \$1 million/month by Rybolovlev.
- **Honorary President of Black Cube:** At the same time, he led the advisory board of Black Cube, another private intelligence firm staffed by former Mossad and IDF agents.

Through Dagan, a direct line can be drawn from Rybolovlev (the client) to Arcanum (the firm) to Black Cube (the partner firm) and finally to Psy-Group (owned by Joel Zamel). This is significant because Psy-Group pitched election manipulation services to the Trump campaign in 2016.

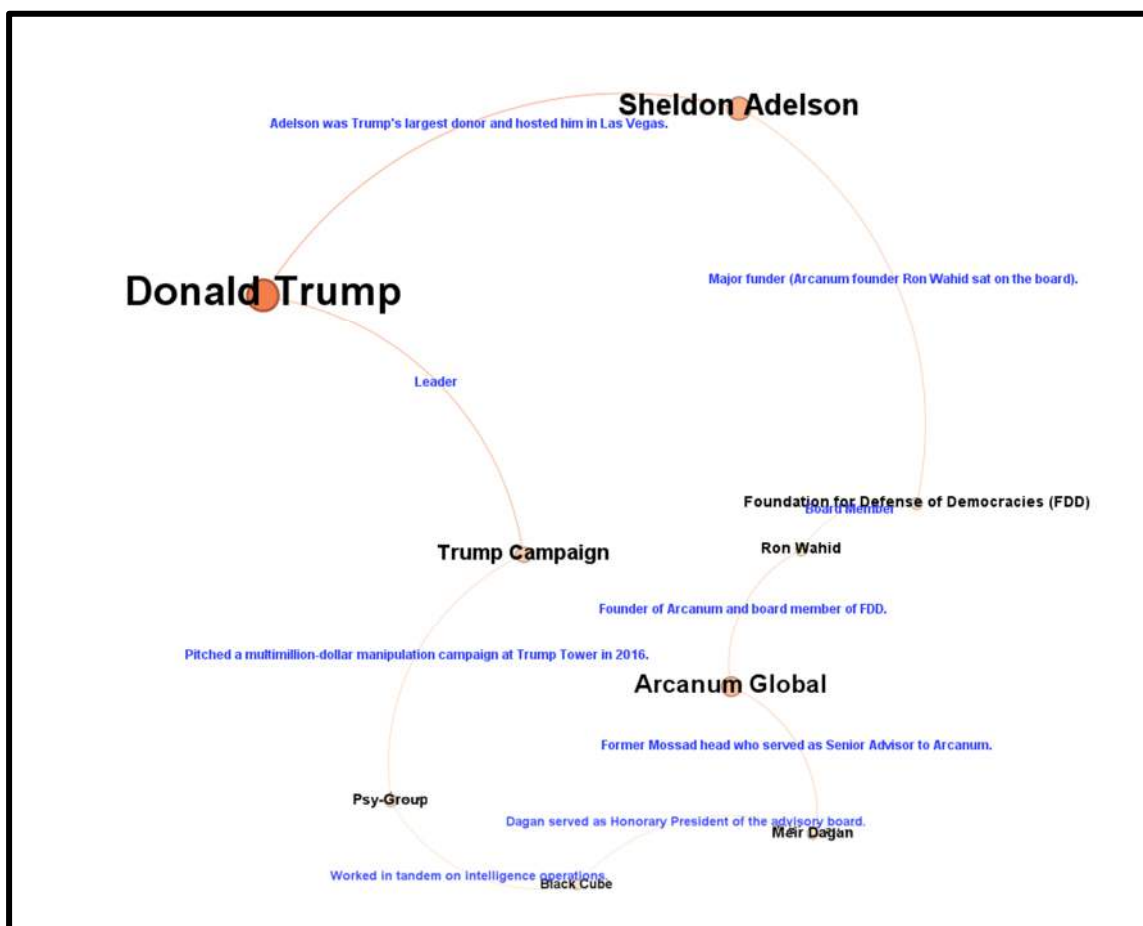
Dagan represents the privatization of high-level state intelligence. Arcanum's leadership (which also included former directors of the DIA and French intelligence) offered state-level capabilities to private bidders, including those on "Putin's list".

"Putin's list" refers to a specific report released by the U.S. Treasury Department in 2018 96 Russian oligarchs whom the U.S. government assessed to be "associated with the Kremlin". The inclusion of Rybolovlev on this list aligns

with a claim reportedly made by Michael Cohen (Trump's former lawyer), who stated that Trump believed Rybolovlev was a **"front for Putin"**. Being named on "Putin's list" is not the same as being sanctioned. Despite being on the list and the subsequent Russian invasion of Ukraine, **Rybolovlev has never been sanctioned by the U.S. or EU.**

Epstein was aware of the private intelligence players, evidenced by his communications regarding Gulf diplomacy and his knowledge of Rybolovlev.

Meir Dagan provided the credibility and connections that linked Russian oligarchs (Rybolovlev) to Israeli operatives (Black Cube/Psy-Group). **Sheldon Adelson** provided the financial fuel and physical infrastructure (Las Vegas) for the policy network these firms supported. **Jeffrey Epstein** navigated this web, brokering connections and mapping the disguised financial flows between these power centres. **Rybolovlev** and other oligarchs, such as **Oleg Deripaska** (this one under sanctions) were clients of those firms.



This is the network that depicts the connection between the Israeli-based private intelligence ring, Trump and Rybolovlev.

5. CONCLUSIONS

One of the main issues here boils down to the fact that **Israeli intelligence (Mossad) is likely to be aware of any Russian meddling** in the elections in the U.S. and it is relevant to understand the stance of the current U.S. administration regarding the Middle East.

Trump cautiously tries to keep Israel and Russia satisfied with U.S. actions in the various scenarios where both countries play a role. Syria and Iran are the most problematic due to the antagonistic interests of Russia and Israel in those scenarios which, in fact, are the same one.

Another issue which can be concluded is the existence of an ecosystem of influence. In it, boundaries between Russian money, Israeli intelligence capabilities, and American politics blur. The "connective tissue" consists of firms like **Black Cube, Psy-Group, and Arcanum**. These firms are staffed by former intelligence chiefs (Mossad, CIA, DIA, French Intel) who privatized their state-level capabilities.

This network served as a conveyor between Moscow (Deripaska/Rybolovlev), Riyadh (MBS), and the Trump orbit (Don Jr./Trump Tower), **often shielded by offshore structures** in Cyprus and the British Virgin Islands.

Trump dealt with Rybolovlev (a suspected "front for Putin"); Rybolovlev and Deripaska hired private intelligence firms (Arcanum, Psy-Group); **and those firms simultaneously served the Trump Campaign** (via pitches) **and Russian intelligence agents** (like GRU operative Jan Marsalek³). Epstein characterized this network as a machine for "disguised payments" and policy influence.

Connections are loose, open to interpretation and hard to prove. Expertise in intelligence indicates that there are too many coincidences of individuals and firms which reveal a **certain connection between Trump and Russian intelligence assets (oligarchs connected to the Kremlin)**. Epstein was playing a political role in the Middle East which is out of his sphere of interest and professional activity.

³ The former COO of the collapsed German fintech Wirecard, Marsalek was revealed to be a long-time recruit of Russian intelligence (GRU/FSB) who now resides in Moscow under a false identity. Before his flight in 2020, he utilized Wirecard funds to finance Russian mercenary operations and orchestrate surveillance on journalists. His critical link to this network is **Arcanum Global**: Marsalek was a client of the same private intelligence firm that served Dmitry Rybolovlev. This created a scenario where a firm staffed by former U.S. and allied intelligence directors was simultaneously working for the "Russian who bought Trump's house" and an active Russian military intelligence agent.

It also reveals a connection with diplomatic and intelligence channels on Epstein's part.

Israel has known about interference in U.S. elections from the start and understands who directed, funded, participated in, or knew about these actions. That gives Israel leverage. The same goes for Saudi Arabia and Gulf monarchies. Since March 2015, Netanyahu was the head of the government, and he was in power when the meeting at Trump tower took place on 3 August 2016⁴. All of these actors shared the same goal as Putin's. **None of them wanted Hillary Clinton to become the next POTUS.**

6. EDUCATED GUESS

Most likely, Putin and Netanyahu agreed on facilitating Trump access to the Oval Office. Israel and Russia prompted the Gulf monarchies to pay the expenses. Israel facilitated its private sector to carry out the task, so that in case of trouble (i.e. the plan did not work) Jerusalem could be detached from it. Russia mobilised its assets to keep control of the development of the plan (ATP linked to Russian intelligence agencies supervised the digital realm and oligarchs linked to Trump's entourage controlled the human factor).

Epstein was caught in the crossfire and being an acquaintance of some of the actors, he got a glimpse of what was going on. He also enjoyed playing a role, cultivating his relationship with Steve Banon and the Gulf monarchies. In the end, information is always an asset for businessmen, if he were simply that.

Monaco was just a nice landscape where spying, politics and business met.

7. PENDING ISSUES

Any of this happened overnight. Trump's relationship with Russia needs clarification. **Is it a business issue, a debt or is it related to other type of *kompromat*?** Why was he

⁴ This gathering on August 3, 2016, was arranged by Blackwater founder **Erik Prince**. Attendees included Donald Trump Jr., Trump advisor Stephen Miller, **George Nader** (representing the Crown Princes of Saudi Arabia and the UAE), and **Joel Zamel** (owner of the private intelligence firm Psy-Group). Nader reportedly told Trump Jr. that the Gulf princes were "eager to help" his father win, while Zamel pitched a multimillion-dollar social media manipulation campaign. Notably, Zamel's firms were simultaneously performing work for Russian oligarchs **Oleg Deripaska** and **Dmitry Rybolovlev**. Following the election, Nader paid Zamel \$2 million for "undisclosed reasons."

surrounded by so many individuals who had a relationship with Russia and the Kremlin as it **revealed the Mueller report?**

It is also remarkable the role that Trump's son-in-law, **Jared Kushner**, played in his first mandate as well as he discreetly is in this second term. He seems to be of great value for the President. Trump has always been very well connected with the Jewish community (Kushner, Adelson, Cohen and many more).

Netanyahu, Trump, Putin and MBS⁵ are in power ten years later. Putin and MBS have no merit in remaining in it, but for Netanyahu and Trump is a different story.

Rybolovlev received a lot of trust by all the parties: the Kremlin, Jerusalem and New York (Trump's headquarters). He has not been sanctioned so far.
